Temporary Quarters Subsistence Allowance (TQSA) Temporary Quarters Subsistence Allowance is a non-taxable supplement for employees traveling to/from an overseas duty location on official travel orders and authorized Living Quarters Allowance. This allowance covers expenses for lodging, meals, laundry and dry cleaning not to exceed maximum allowance.
